**NOTE (1):** The scheme is for a period of five (5) years (likely to be extended).

**NOTE (2):** The Chair position is a tenure post. However, an incumbent may as well be on deputation.

**NOTE (3):** The above pay bands (except for the Research Officers) carry other allowances admissible as per Government of India rules. These pay bands are the revised pay bands as per the recommendation of the 6<sup>th</sup> Central Pay Commission and as accepted by the Government of India.

**NOTE (4):** Besides normal age relaxation for the reserved categories, Ex-serviceman and in-service personnel as per Govt. of India rules, further age relaxation to an otherwise qualified candidate shall also be considered depending upon experience and other added/ higher qualification(s).

**NOTE (5):** With regard to age limit (wherever prescribed), the crucial / calculating date shall be the last date of receipt of applications as mentioned in the advertisement.

Candidates with higher qualification(s) will be preferred. It is to be noted that mere fulfilment of eligibility criteria shall not entitle a person for consideration. The decision of the Screening Committee(s) appointed for the purpose of short-listing candidates from amongst the applications received, will be final and binding. The University reserves the right to fill or not to fill any of the vacancies or to increase the number of posts, as required.

The envelope containing the application form should be superscribed as “**Application for the post of ...(name of the post)**”. **A non-refundable application fee of Rs. 500/-** (for the post of MHRD IPR Chair Professor) / **Rs. 200/-** (for the posts of Research Officer and Stenographer cum Documentation Assistant) (Exempted for SC/ST/Persons With Disability) in the form of **Demand Draft only** drawn on any nationalised bank in favour of **The Registrar, Tezpur University**, payable at Tezpur, must be submitted along with the application. The Demand Draft should not be drawn before the date of issue of this advertisement and should remain valid at least for six months. Candidates must write their names and the post applied for on the reverse of the Bank Draft.

Candidates willing to apply for two or more posts must submit separate application and fee, if any, for each post.

Application(s) received after the last date [due to postal delay or any other reason(s) thereof] or incomplete in any form or without the application fee, shall be summarily rejected. Those in employment must apply through proper channel or submit ‘No Objection Certificate’ from the concerned employer.
