**B. TECH ADMISSION MAIN LISTS  
(Reserved for the NE States)**

Subject to verification of original documents, medical examination and satisfaction of the minimum qualification requirements the candidates in the lists below have been provisionally selected for admission into the B. Tech. programme 2010-11, based on their AIEEE All India Ranks. The allocation of discipline shall be done at the time of admission based on their Ranks and availability of seats in the desired discipline against specific categories.

The candidates are to report to the in-charge of admissions at the Admission Hall, Tezpur University campus at **9.00 am on 15<sup>th</sup> July, 2010** for credential verification, counseling, and admission. The presence of the candidate at the time of admission is mandatory. **In case a candidate fails to report for admission on the specified date he/ she will forfeit his/ her chance for admission.** The candidate shall produce the documents stated below in original for verification and submit attested copies of the same for future reference and record.

1. AIEEE score card.
2. Pass certificates of all examinations conducted by the Board/ Council.
3. Mark sheets/ grade cards of all examinations conducted by the Board/ Council.
4. A character certificate from the head of the institution last attended.
5. Valid SC/ST /OBC-NCL/ Persons with Disability (PWD) certificate issued by the competent authority for those selected under reserved category.
6. Latest OBC-Non-creamy layer certificate **in the prescribed format** issued by the competent authority for the candidates claiming admission against OBC- NCL seats.
7. Certificate of HSLC or equivalent examination for Date of Birth.
8. **Permanent Resident Certificate in the prescribed format.**
9. Gap certificate from the District Police Authority or Court Affidavit, in case of a gap of one year or more in study after passing the qualifying examination.
10. Three copies of recent passport size photograph.
11. Affidavits in non- judicial stamp paper signed by the candidate and parents/ guardian and countersigned by the Oath Commissioner (Notary) as per the attached formats. Candidates are advised to visit the website [www.ugc.ac.in](http://www.ugc.ac.in) or [www.tezu.ernet.in](http://www.tezu.ernet.in) for UGC Regulations on curbing the menace of ragging in Higher Educational Institutions, 2009. Candidate will be also required to submit the attached **undertaking** duly filled in along with attested copies of other documents at the time of admission.
12. The call letter issued from the office of the Controller of Examinations.

Candidates failing to produce the documents stated above will not be admitted. However, certificate and marksheet of the qualifying examination will not be insisted upon for those whose results of qualifying examinations are awaited. Candidates will be required to pay an amount of Rs 18069/- in cash or by DD drawn in favour of the Registrar, Tezpur University payable at Tezpur on account of admission. This amount includes the hostel admission fee of Rs 4000/-. Candidates belonging to SC/ ST category will be exempted from paying hostel seat rent of Rs 675/- on production of the Caste certificate

It is to be noted that the new academic session will start on 2nd August, 2010. Hostel seats to the admitted students will be available from 30.07.2010. Course registration will be done in the department concerned on 30.07.2010. Candidates should come for attending classes accordingly.

If the candidate is continuously absent from the class for a week during the first month without permission from the Dean, School of Engineering his/her seat will be cancelled without notice.

Special bus service from Tezpur ASTC Bus Stand to Tezpur University will be available at 8:10 a.m.
