1. An **Affidavit** (given hereunder) on a **Rs. 10/- stamp paper** at the time of admission. Apart from the student's signature, his/her parent's/guardian's signature also is required.
2. Fill the **Admission Form** given herewith and bring it along with the following documents.
3. Originals and photocopies of -
 - a. **Mark Sheets** and **Certificates** from Class X to Graduation;
 - b. **Photo Identity Cards** (Voter's ID Card, Driving License, Aadhaar Card, PAN Card);

- c. **Category Certificate** (SC, OBC)
 - d. **Income Certificate/NCL Certificate** issued by Revenue Officer not below the rank of Tehsildar/Circle Officer. Income declaration of self-employed parents/guardian should be in the form of a certificate issued by the Revenue Officer. Employed parents/guardians are required to obtain Income Certificate from their employers and submit a consolidated certificate from the Revenue Officer including any other/additional sources of income.
4. Two copies of recent **passport size photographs**.
