

Memorandum of Understanding

Between

The Management & Science University (MSU) and Tezpur University, India, wishing to formalize and intensify existing cooperative relations, and for developing programs of academic and cultural exchange, agree as follows:

PART I

SCOPE OF COOPERATION

The areas of cooperation shall include, subject to mutual consent any program offered at either institution that is felt to be desirable and feasible and that will contribute to fostering and enhancing collaborative relationships between the two parties. The assistance to be provided by each of the contracting parties may include teaching, research, exchange of faculty, exchange of students and such other areas as deemed beneficial by the two institutions.

PART II

AREAS OF COOPERATION

Assistance shall be carried out, subject to the approval from both parties for the following mobility activities;

1. Exchange of students and faculty - short courses, summer programs, semester abroad
2. Joint educational and research activities
3. Dual and Double degree programs
4. Exchange of academic material and academic publications
5. Participation in seminars, joint conference and academic meetings

The terms of such mutual assistance and necessary budget for each program and activity shall be discussed and agreed upon in writing by both parties prior to initiation. Each part shall designate a liaison officer to serve as the point of contact to manage the details of program development.

PART III

INTELLECTUAL PROPERTY RIGHTS

The parties agree that the ownership of and any other rights relating to intellectual property arising from or in connection with any programme or activity under this Memorandum of Understanding shall be determined on a case by case basis, and shall therefore be specified and agreed for each such programme or activity in a separate written agreement between the Parties.

PART IV

CONFIDENTIALITY

The parties agree and undertake to keep confidential at all times any information or data that may be exchanged, acquired or shared in connection with any programme or activity conducted pursuant to this MoU save where the same is already in public domain.

PART V

EFFECTIVE DATE AND LENGTH OF AGREEMENT

This agreement will remain in force until and unless there is reason for termination. Any amendment and/or modification of this agreement will require written approval of the Management & Science University and Tezpur University, and shall be appended here to. Either party reserves the right to terminate this agreement upon six (6) months' written to the other.


