### All shortlisted applicants are hereby requested to take note of the following:

- 1. The PI will be held online, through Google Meet, on **27<sup>th</sup> and 28<sup>th</sup> June 2024**. The PI will be held in two sessions every day starting at 10:00 A.M. (IST) and 03:00 P.M. (IST) respectively.
- 2. Candidates are requested to be ready for the PI, along with the requisite technical arrangements, on the stipulated date and time as per the schedule given. Technical issues of any kind at the candidate's end, affecting the interview in any manner, will not be considered to reschedule the interview.
- 3. Applicants will receive the link/invite/meeting-ID for the interview in their respective email accounts/mobile phone number (provided by them in their applications), just before the interview. Once this invite/link is received, they should join the meeting immediately.
- 4. In case any applicant is willing to submit updated email id/ mobile phone number, they can do the same by sending an email to tu\_law@tezu.ernet.in before 25<sup>th</sup> June 2024.
- 5. It is to be noted that eligibility of the shortlisted applicants for admission, if selected through PI, is provisional and subject to verification of documents pertaining to the qualification of the candidates.
- 6. The selection to the programme of PhD in Law, in the Autumn semester, 2024 will be based on the following two components:
  - a. A research proposal to be submitted by each applicant through email.
  - b. Performance of the applicant in Personal Interview, to be conducted in online mode.

## **Instructions for submission of the Research Proposal:**

- a. The proposal must include following components:
  - i. Title
  - ii. Background of the Study
  - iii. Statement of Problem
  - iv. Aims and Objectives
  - v. Research Questions
  - vi. Scope and Limitations
  - vii. Research Methodology
  - viii. Tentative Chapterisation
  - ix. References [in Oxford University Standard for Citation of Legal Authorities (OSCOLA) style]
- b. The maximum word-limit of the proposal, excluding the References, is 2500 words.
- c. The ethics of citation and referencing should be maintained in the proposal. (Plagiarism check will be done through software).
- d. The proposal should be typed on A4 paper size with default margin, 12 font-size, 1.5 spacing in MS Word.
- e. The proposal should be submitted by 05:00 PM (IST) **26<sup>th</sup> June 2024** through email to tu law@tezu.ernet.in.
- f. The subject of the email should be "PhD in Law Admission Research Proposal: Autumn 2024".
