ABOUT THE ONE DAY VIRTUAL BASIC TRAINING PROGRAMME ON HUMAN RIGHTS

Human rights are basic, fundamental, and inalienable rights that all human beings are endowed, by virtue of being a human. The National Human Rights Commission (NHRC) was set up under the Protection of Human Rights Act, 1993 and the State Human Rights Commission also came up under the same Act. Both the NHRC and SHRC have been mandated to promote and protect human rights in India.

In pursuance of the above mandate, the need of spreading awareness on basic human rights among students and

the observation of International Human Rights Day, the Department of Law in collaboration with NHRC, is organizing a day-long online training programme on human rights through Google meet platform on 12.09.2023.

The programme shall be conducted online through virtual platform which will accommodate 50 participants across the Northeast States particularly from Assam. Participants include enrolled students, teachers, administrative officers, and staff of educational institution.

PARTICIPANT ELIGIBILITY

- ✓ Students, Teachers, Administrative officers, and staff of educational institution. Participants from Northeast States particularly from Assam are encouraged to apply.
- ✓ Acceptance of participants will be on first come first basis who does not have exposure to human rights concepts and discourse.
- ✓ Participation is free and each successful participants will be provided with Certificate of Participation and a stipend of Rs.500/- (provide bank details, pan card and Aadhaar card)
- ✓ Last date to apply is 10th September 2023 (Sunday), before 5.30 p.m.

- ✓ Attendance in all the session is mandatory.
