#### Mode of application: Online

#### Selection Process:

Two-tier selection process i.e. screening of eligible applications by an Internal Committee, followed by final selection through an Expert Committee shall be used. However, the selection process will be expected to complete within 6 months from the last date of submission of application at the DST and the result of the selection process will be communicated to individual selected candidate through online web portal (<a href="www.online-inspire.gov.in">www.online-inspire.gov.in</a>) only. No hardcopy of the Offer Letter (Provisional & Final) shall be sent to the candidate by any other modes.

#### **Eligibility:**

- •INSPIRE Scholar having secured minimum 70% marks in aggregate or equivalent CGPA at M.Sc. or Integrated MS/ M.Sc. course.
- •1<sup>st</sup> Rank Holders at University Level Examination (not at Autonomous College Level Examination) of overall full time post-graduate program in science, engineering/technology / agriculture / pharmacy / other applied science streams and undergraduate in Medicine i.e. MBBS. #### 5. Release of Fellowship amount:

- •The fund with respect to INSPIRE Fellow(s) shall be made available with the Host institution by the Department of Science & Technology, New Delhi for payment of the Fellowship along with Contingency Grant to the Fellow(s) following Government of India and Institute / University norms. In such case, Host institute require to register in PFMS (Public Finance Management System: https://pfms.nic.in) and needs to provide unique agency code and details of authorized account of head of institute, to DST.
