He apprised the members specially the new members that the NIRF ranking of Texpur University is 29th amongst the Universities in the Country. He congratulated all the faculty and students for their achievements and appealed to them to continue with their hard work to scale greater heights in the coming years. The Vice- Chancellor



congratulated the three students of the Department of Mechanical Engineering for receiving the Gandhian Young Technological Award. He also informed that the UGC has accorded approval for starting four new Departments and discussed the matter of starting the new Departments in the agenda of the meeting. The Vice- Chancellor called upon the Controller of Examinations to present the Agenda Items of the meeting.

Discussion	 Prof. Harish Kumar Sharma suggested to keep the provision for direct admission of rank holder candidates to undergraduate programmes open for all the states instead of only NE states. DSW conveyed the concern of the committee constituted to frame a guideline on admission of Sports person that allotment of 5% additional marks in the TUEE as decided in the last AC meeting may not cover up for selection of Sports person as generally they are weak academically. The Vice Chancellor suggested that the present policy will not be changed for the current academic session. He also suggested to the DSW to submit the recommendation of the committee for which the committee was constituted. Prof. R.C. Deka informed that the committee constituted to frame a guideline on uniform system for conversion of percentage of marks to letter grade for the programmes of the University is working and they need some more time to submit the final report. The Convener of the Academic Regulation revision committee placed some queries and got it clarified which will help them to incorporation in the revised Regulation of Academic matters. Further, the meeting suggested to make the eligibility criteria uniform specially the cut off marks of the qualifying examinations across the school, for admission. There was a long discussion on the matter of calculation procedure of SGPA. In the existing rules the SGPA is calculated taking into account of

	the number of credit registered by the students and passed grades in a semester. The Vice Chancellor strongly suggested that the SGPA must be calculated on the basis of the credits of all the courses registered by the students including failed courses. Some members expressed different views on this matter. The Chairman advised the committee to submit the regulation as the earliest possible which will be discussed separately in another meeting.


