2. The appointment shall be on probation for a period of 02(two) years from the date of their joining, and probation shall be regularized subject to satisfactory performance.

3. The appointment may be terminated at any time by a month's notice given by either side viz., the appointee or the appointing authority, without assigning any reason. The appointing authority however reserves the right to terminate the service of the appointee forthwith or before the notice by making payment to him/her of a sum equivalent to the pay and allowances for the period of notice or the expired portion thereof.

4. The appointment carries with it the liability to serve in any part of Arunachal Pradesh as well as in the establishment of Government of Arunachal Pradesh located outside Arunachal Pradesh at the discretion of the Government.

5. The appointee shall complete 02 years mandatory probation in their initial posting place. No representation from appointee in this context will be entertained.

6. If any declaration given or information furnished by the candidate proves to be false or if the candidates are found to have willfully suppressed any material information, he/she shall be liable for removal from service and such other action as Government deems necessary.

7. The appointment will be further subject to:

(i) Taking an Oath of allegiance and faithfulness to the Constitution of India (or making of solemn affirmation to that effect in the prescribed form on joining.

(ii) Production of Release order/NOC from the previous employer (applicable in the case of persons who are already in Government service).

(iii) Production of original Educational Qualification certificate and all other testimonials for verification at the time of joining.

(iv) Production of Disability certificate in respect of candidate selected under PwD quota.

(v) Any training as and when assigned to him/her by the Government must be attended without fail.

8. The appointed officers are directed to report (along with original educational qualification certificate including all other testimonials for verification) to the Department of Personnel, Block IV, 4<sup>th</sup> Floor, Room 3, A.P. Civil Secretariat, Itanagar and submit their joining report within 1 (one month) from the date of issue of this order.

9. Order for posting of officers shall be issued separately.


10. The other terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.

7. You will neither leave the University during mid-semester, nor apply anywhere without taking prior permission from the competent authority. Your absence from duty continuously for more than five days without any information may be considered as resignation (without notice) from the service.
8. During the probation period, one month's prior notice or payment of one month's salary, in lieu thereof, would be payable for resigning from the post.
9. You will either have to pay one month's salary towards security deposit in lump sum against the salary in lieu of notice period or you will have the option of paying the security deposit by authorizing the University to deduct @10% of your gross salary per month for 10 months. In the case of choosing the second option, you will have to submit a letter of authorization in the prescribed format as enclosed. The security deposit will be refunded to you at the time of your being released from the employment of the University, as per norms and rules.
