NOTIFICATION

This is for information of all concerned that in pursuance of para 6 of the instructions issued vide O.M. No. 3(1)/2008-E.II(B) dated 29.08.2008 of the Ministry of Finance, Department of Expenditure, Govt. of India, as per which the rates of Special Compensatory (Remote Locality) Allowance (SCRLA) shall automatically increase by 25% whenever the Dearness Allowance (DA) payable on revised (6th CPC) pay structure goes up by 50% and as per the subsequent guidelines issued by the same department in relation to implementations of the 7th CPC vide para 3 of O.M. No. 11/1/2017-E.II(B) dated 18.07.2017, the employees will have the additional option to avail of the benefit of SCRLA as per 6th CPC rates along with Special Duty Allowance (SDA) at revised (7th CPC) rates, all the employees of Tezpur University, consequent upon enhancement of rates of DA as per the 6th CPC pay structure from 148% to 154% w.e.f. 01.01.2019 and again from 196% to 203% w.e.f. 01.01.2022 vide Ministry of Finance, Department of Expenditure, Govt. of India O.M. No. 1/3(1)/2008-E.II(B) dated 08.03.2019 and O.M. of even number dated 07.04.2022, will be entitled to Special Compensatory (Remote Locality) Allowance (SCRLA) at the following revised rates with retrospective effect and arrears, if any, on account of the said enhancement in the rates of SCRLA will be paid to them.
