

OPPORTUNITIES

Direct Admissions:

Tezpur University accords a high priority to the internationalization of its teaching and research programs. The University has been accepting students from various countries.

The Office of International Affairs coordinates the University's international collaborations in close contact with the university leadership, various faculties and departments. The office is responsible for the University's bilateral agreements and participation in networks and organizations.

Please check the prospectus, which is available on the academic website: <https://www.tezu.ernet.in/academic/admission2025/> for minimum qualifications, eligibility requirements, tuition fee etc. Following are the documents to be submitted along with the application if you want to come in as a self-financed student / scholar;

Copies of marks sheet from High School onwards (10th, 11th & 12th grade transcripts); Bachelor's and Master's transcripts (depending on the program you are applying for)

- Copy of Passport
- Proof of financial support (bank statement for the last three months)
- Two letters of recommendation from your faculty members (the letters must be on the letter head of the faculty members or they can email us directly through their official email id)
- Research Proposal and Synopsis (in case of PhD applicants)
- C.V (in case of PhD applicants)

Attached is a copy of the application form for admission of foreign nationals, which may be downloaded and filled out. The soft copy of the above documents must be sent to diatu@tezu.ac.in before closing date of application form.

Eligibility:

a) Applications: The University may consider the admission of foreign nationals, their admission under the 25% bracket for International Student, to any programme, is subject to the condition that they are found suitable for admission by the Admissions Committee of the Centre/Department/School.

b) Academic qualification: A prospective Foreign National has to fulfil the eligibility conditions, including the required qualifying degree and marks/grades, as prescribed for Indian students. These conditions can be found in the prospectus which is available on the University website. In case a student's parent University does not have a program which is prescribed as minimum eligibility condition, equivalent program may be considered. In this respect the Admission Committee's decision is final.

1. NRI's with Indian Passport are Indian Nationals and therefore, cannot be considered as International Students.

2. Foreign Nationals whose qualifying degree is from India and who are resident in India at the time of application, in order to be considered for admission into any program/course should take some part of the entrance examination in the form of interviews in the University as prescribed by the Centre/ Department/School.

c) English proficiency: Foreign students should have a certificate of English language proficiency issued by a recognized language institute such as TOEFL or IELTS or by a duly qualified University teacher of English.

Applications should be accompanied by copies of relevant certificates, marks sheets together with the English version of such copies duly attested, if they are in a different language. All foreign nationals seeking admission to the University will be required to produce a medical certificate of fitness from a recognized hospital in their country. Those offered admission may also be required to undergo a comprehensive medical examination as prescribed by the University.

Visa & Health Insurance:

A candidate selected for admission is given provisional intimation of admission, which can be used by the candidate to obtain VISA from his/her local Indian Consulate. It is essential that a Ph.D. student should obtain a "Research VISA" and other students a "Student VISA". Prospective applicants for Research VISA needs to submit to the Consulate a research proposal along with University's provisional acceptance of affiliation.

IMPORTANT NOTE: No foreign national will be admitted without a student visa. Foreign nationals selected for Ph.D. programmes will be allowed to complete the admission only after obtaining a Research Visa from the Indian Embassy abroad.

Health Insurance:

All the prospective students are required to buy an appropriate health insurance policy before arriving in India. It is essential that the student's health insurance policy remains valid throughout the period of the student's stay in this University. This will be checked at the time of admission.

Accommodation:

If requested, hostel accommodation may be provided at various Men's and Ladies' Hostels of the University campus as per university norms.

Registration at the FRRO:

Under the Registration of Foreigners Rules 1939, every foreigner who is in India, for stay in excess of (90) ninety days (for purpose of other than tourism) is required to register himself/herself within (14) fourteen days of arrival in India with the Foreigners Regional Registration Officer in the place of ordinary residence and declare his/her registered address.

1. ICCR:

About ICCR Scholarship Program

India is well known as an education hub attracting international students from all over the world. India's robust education system, in the backdrop of its rich diversity and vibrant culture & history, affords a broad range of options for students. And as a rapidly growing country with a leading technological edge, studying in India has much to offer, whether it is Engineering, Computers, Sciences and humanity and social sciences etc.

Indian Council for Cultural Relations administers various scholarship programs annually and awards about 3000+ scholarships under 26 different schemes to foreign students from about 140 countries. Amongst these 23 schemes, six are funded by ICCR from its grant and others are administered on behalf of MEA and Ministry of Ayush. The portal contains all relevant information regarding ICCR sponsored scholarship schemes and other information like names of the Indian Universities, courses offered by them and guidelines of scholarship schemes etc.

The Study In India (SII) programme is a flagship project introduced by the Ministry of Education (MoE), Government of India. The SII portal (www.studyinindia.gov.in) was jointly launched on 18th April 2018 by the former Minister of Union External Affairs, Late Smt. Sushma Swaraj and former Minister of State for HRD, Dr Satya Pal Singh at the India Habitat Centre in New Delhi.

The Study in India programme seeks to endorse India as a prime education hub for international students by inviting them to pursue their higher education in the country. With an attractive set of salient features, the programme is the perfect platform for international students to experience the best of what Indian education has to offer. Therefore, it encourages international students to explore valuable educational opportunities enabled by the top Indian universities.

- I. The added advantage of the Study in India Programme is quality assurance wherein it partners up with institutes that:
- II. have National Assessment and Accreditation Council (NAAC) accreditation of 3.26 and above, or
- III. are ranked among the top 100 in any category except medical by the National Institutional Ranking Framework (NIRF), or
- IV. have the status of Institute of National Importance (INI) or Institute of Eminence (IOE).

The autonomous body NAAC is an institution established by UGC whereas NIRF, is a framework outlined by the Ministry of Education (MoE) in 2015 is a framework outlined to assess and rank Indian higher education institutions across the country on parameters such as teaching-learning, infrastructure and learning resources, etc.
- VI. As the Study in India programme is maturing, the aim is to jump the geographical boundaries and reach out to every international student who dreams of gaining top-notch higher education. The long-term goal is to help international students not only to take admission to the finest of institutes but empower them with all-around development.
