Subject: Release of Grant-in-aid (non-recurring) to Tezpur University, Assam for creation of barrier free environment in the of Tezpur University, Assam under the SIPDA Scheme during 2015-16

Sir,

I am directed to convey the sanction of the President of India to the expenditure of Rs. 225.58 Lakh and release of an amount of **Rs.1,12,79,000/- (Rupees One Crore Twelve Lakh Seventy Nine Thousand only)** (50% of Rs. 225.58) as 1<sup>st</sup> installment to Registrar, Tezpur University, Assam for creation of barrier free environment in the University under the Scheme for Implementation of Persons with Disability Act, 1995 (SIPDA) during 2015-16. The 2<sup>nd</sup> Installment of Rs.1,12,79,000/- shall be considered after receipt of progress report and utilization of 75% of 1<sup>st</sup> installment.

2. The detailed break-up of Rs.2,25,58,000/- (Rupees Two Crore Twenty Five Lakh Fifty Eight Thousand only) is at Annexure.

3. Purpose for which this grant is sanctioned: Creation of Barrier free environment in the Tezpur University, Assam.

4. Certified that this sanction has been noted at **Sl. No. 28** in Register of Grants (maintained in Form GFR-39) for the year **2015-16**.

5. The Grants-in-aid will be regulated in accordance with the provisions contained in the General Financial Rules (GFR), 2005. The Grants-in-aid is also subject to the Chapter 9 of the General Financial Rules, 2005, as amended from time to time and read with the Government of India's decisions incorporated there-under, and any other guidelines which may be issued in this regard, and in particular to the following conditions: -

(i) All relevant information and documents /certificates as required under GFR 2009 have been received.

(ii) Certified that the pattern of assistance of rules governing such grants-in-aid have received the approval of the Ministry of Finance, as required under Govt. of India Decision No. (1) under DFPR-Rule 20.

(iii) The accounts of the Tezpur University, Assam shall be open for audit by C&AG or by any person authorized by him on his behalf in accordance with the provisions laid down in Section 14 of the C&AG (DPC Act 1971) as amended from time to time.

(iv) The accounts of the Tezpur University, Assam shall be open for inspection by the Sanctioning Authority and Audit, both by the Comptroller & Auditor General of India under the

revision of C&AG (DPC Act, 1971) and Internal Audit by the Principal Accounts Office of the Ministry or Department whenever it is called upon to do so.

v) Grants-in-aid to the Tezpur University, Assam is subject to the economy instructions issued from time to time by the Ministry of Finance or by any other Competent Authority.

vi) (a) No Grant-in-aid was released earlier to the Tezpur University, Assam under the SIPDA Scheme.

(b) Rules and Regulations as per GFR would be applicable.


vii) The funds allocated under this Scheme cannot be diverted to any other programme without prior approval of Government of India. Further, Tezpur University, Assam will strictly adhere to timelines without escalation in cost and delays for completion of the work.

viii) Tezpur University, Assam will confirm that the conditions mentioned in the Sanction Order are acceptable to them and they are exempted from executing the bond.

(ix) The grant-in-aid is further subject to the following conditions:-

- (a) The Implementing Agency shall submit the final Utilization Certificate for the entire grant along with a project completion report within three months after completion of the work/project as stipulated in the proposal. Unutilized money, if any, is to be refunded to the Ministry. In case the work/project is not completed within the stipulated timeframe and further time is sought to complete the same, the organization concerned has to intimate the Ministry and also explain the reason for the delay. If the project is not completed within the timeframe/extended timeframe, the organization concerned has to refund the grant forthwith.
- (b) Tezpur University, Assam shall furnish to this Ministry monthly progress report on the project indicating both physical and financial achievements in relation to the approved project.
- (c) The work has to be allotted as per terms and conditions laid down in General Financial Rules (GFR) /Codal Procedure/CVC Guidelines in the matters of contract/financial transactions.
- (d) All other terms and conditions as laid down in GFR would be applicable.
- (e) The Implementing Agency will maintain a website and prominently display details of grant-in-aid received, purpose thereof, events organized and list of beneficiaries, wherever applicable.

6. Arrangement may be made for disbursement of Rs.1,12,79,000/- (Rupees One Crore Twelve Lakh Seventy Nine Thousand only) to the grantee institution through electronic transfer to Tezpur University, Assam in saving Account No.10501586319, IFSC Code-SBIN0000195, MICR CODE-784002002 in State Bank of India, Branch-Main Branch, Tezpur, Lake Road, Tezpur, Sonitpur, Assam.
