Due to COVID-19 pandemic situation, students were asked to vacate University Hostels w.e.f. 18.03.2020. As per guidelines of Ministry of Home Affairs (MHA) Order No. 40-3/2020-DM-I(A) dtd. 30th September 2020, the following Ph. D Scholars admitted in Spring Semester 2020 in the Science and Technology stream having laboratory experimental works are being allowed to return to their respective Hostels during the period 23.12.2020 to 31.12.2020, provided they are neither infected by COVID -19 nor undergoing any COVID-19 treatment. They are asked to remain quarantined for 14 (Fourteen) days in their hostel rooms as per the guidelines of UGC for re-opening the Universities and Colleges post lockdown due to COVID-19 pandemic (D.O. 14-8/2020 (CPP-II, dtd 5th November, 2020).

They need to take hostel admissions as per University norms. They must submit an undertaking to the Hostel Administration as per the format attached herewith and abide by the following norms (SOP).

- a) Undergo Rapid Antigen Test (RAT) three days before coming to the hostel. The report of RAT must be submitted to hostel administration at the time of entry to the hostel.
- b) Keep himself/herself quarantined in the allotted room of his/her hostel for 14 days from the date of his/her entry to the hostel room and keep himself/herself be isolated from his/her fellow boarders during this period.
- c) Undergo Rapid Antigen Test (RAT) after completion of 14 days quarantined period and if test result appears negative then they will be allowed to resume their academic activities.
- d) Remain alert about himself/herself and fellow boarders with signs and symptoms i.e., fever, cough, body ache and difficulty in breathing. If any such signs appear, they will immediately contact the concerned University Authority for necessary action.
- e) "Wear Mask, Follow Physical Distancing, Maintain Hand Hygiene"
- f) Aren't allowed to venture out of the University campus until further notice.
- g) Maintain proper social distancing and hygiene in the Hostel.
- h) Avoid any gathering.
- i) Follow COVID-19 norms notified from time to time by Government of India or by the University
- j) Liable for any disciplinary action as per University Rules and Regulations, COVID-19 pandemic norms and Hostel Rules, 2019 in case of violation of the prescribed guidelines.
