NOTIFICATION Dated:10.12.2021

The following full time PhD Scholars admitted under AICTE Doctoral Fellowship Programme and Centre for Multidisciplinary Research, Tezpur University are being allowed to occupy the hostel seat as per the list enclosed herewith. The students may occupy their hostel seats within 12th -25th December 2021, provided they are neither infected by COVID -19 nor undergoing any COVID-19 treatment; and vaccinated against COVID-19. If any student does not occupy the allotted seat/room within the stipulated time (without a valid reason and justification), the same will be allotted to other students. On arrival, students must remain quarantined for 07 (Seven) days in their hostel rooms.

They must take hostel admissions as per university norms and need to submit hostel enrollment form. Without hostel admission, students will not be allowed to occupy the allotted rooms/seat on arrival. They must produce hostel admission proof to the Warden's office. Besides, they also need to submit an undertaking to the warden's office of the respective hostel as per the format attached herewith and abide by the following norms (SOP).

- a) Before coming to the hostel, full vaccination against COVID-19 is compulsory (however who took one dose and waiting for next dose can come to the University with undertaking). A proof of vaccination copy (Hard copy) must be submitted to hostel administration at the time of entry to the hostel.
- b) Undergo RT-PCR/RAT negative test report within three days (within 72 hours) to the time and date of entering the hostel. The negative report of the test must be submitted to hostel administration at the time of entry to the hostel.
- c) Keep himself/herself quarantined in the allotted room of his/her hostel for 07 days from the date of his/her entry to the hostel room and keep himself/herself isolated from his/her fellow boarders during this period.
- d) "Wear Mask, Follow Physical Distancing and Maintain Hand Hygiene"
- e) Download "Aarogya Setu App" in the mobile phone & check regularly
- f) Aren't allowed to venture out of the University campus until further notice.
- g) Maintain proper social distancing and hygiene in the Hostel.
- h) Avoid any gathering.
- i) Follow COVID-19 norms notified from time to time by Government of India or by the University.
- j) Liable for any disciplinary action as per University Rules and Regulations, COVID-19 pandemic norms and Hostel Rules, 2019 in case of violation of the prescribed guidelines.
