Notification (Web circulation)

Pursuant to the decision of the 104th meeting of the Board of Management of the University vide resolution no. B.104/2022/1/2.2, it is notified for all concerned that the University has adopted the guidelines for counting of post-doctoral research experience for promotion of teachers under CAS of UGC Regulations 2018 as under:

- 1) Previous ad-hoc/temporary/contractual service and post-doctoral research experience to be counted in addition to the regular service of the applicant for promotion to next higher level, as per the provisions of Clause 10(f) of UGC Regulations 2018.
- 2) For counting of ad-hoc/temporary/contractual service and post-doctoral research experience for promotion under CAS, the applicant will be required to apply as per UGC Regulations 2018.
- 3) Quality standard of the organizations for consideration of the post-doctoral research experience for promotion under CAS of UGC Regulations 2018 shall be as under:
 - Post-doctoral research experience from **Foreign University/Research Institute** shall be considered only if the concerned university/research institute has a ranking among top 500 in the World University Ranking, at any time, by any one of (i) Quacquarelli Symonds (QS), (ii) Times Higher Education (THE), (iii) Academic Ranking of World Universities (ARWU of the Shanghai Jio Tong University (Shanghai), (iv) Leiden Ranking or (v) among the top 50th percentile in SCImago Ranking.
 - ii) Post-doctoral experience from **Indian University/Research Institute** shall be considered only if the concerned university/research institute has a ranking among top 100 in NIRF ranking. Further, post-doctoral research experience of national laboratories or other scientific/ professional organizations such as CSIR, ICAR, DRDO, UGC, ICSSR, ICHR, ICMR and DBT shall be counted for promotion.
- 4. The University has right to amend the guidelines keeping the UGC guidelines intact from time to time. Any modification in guidelines by UGC/Ministry of Education, Govt. of India shall supersede these guidelines of the University.
