Sealed tenders in single bid system are invited for and on behalf of Tezpur University (TU), for the works as detailed below at TU, Napaam.

The Earnest Money Deposit is to be submitted in the form of crossed Demand Draft / Banker's Cheque / Bank Guarantee from a Scheduled Bank in favour of "The Registrar, Tezpur University", payable at Napaam, Tezpur.

Qualifying criteria for issue of tender document to Intending Parties:

- 1) Registered with Govt./Semi Govt. Department/Autonomous body.
- 2) Experience of having successfully completed similar works (i.e. Supply, Installation, testing and commissioning of High Mast light with all accessories.) during last 7 (seven) years in any Govt. /Semi Govt. Departments/Autonomous bodies **supported by work order and completion certificate**. In case, the work order and completion certificate submitted by a contractor fails to show the work actually meant for issue of tender paper, the party has to submit BOQ of the work along with work order and completion certificate. It should be either of the following:
 - a) Three (3) similar (as stated above) completed works costing not less than the amount equal to 40% of the estimated cost.
Or
 - b) Two similar (as stated above) completed works costing not less than the amount equal to 50% of the estimated cost
Or
 - c) One similar (as stated above) completed work costing not less than the amount equal to 80% of the estimated cost

- 3) Average annual financial turnover during the last 3 years ending 31st March of the previous financial year should be not less than 5.00 Lakhs.
- 4) Application requesting issue of tender document must be accompanied by self-attested copies of qualifying documents as per the qualifying criteria as stated in serial no.1 and 2 above. Tenderers will be required to deposit cash (non-refundable) at the TU cash counter for purchase of tender document. **The cash counter remains open up to 1.00 PM on all working days.** TU reserves the right to accept or reject any or all the applications for issue of tender document without assigning any reason thereof.
- 5) The acceptance of tender will rest with the authority of TU, Napaam, Tezpur who does not bind itself to accept the lowest tender and reserves to itself the right to reject any or all the tenders received without assigning any reason thereof. The work may be allotted in part or whole at the discretion of competent authority of the University.
