Sealed quotations are invited from reputed/authorized vendor experienced in serving Refreshments/Snacks packet to more than 1000 people in programmes related to student/staff/guest of any academic institution for providing Refreshment/Snack Packets to the participants of XIVth Convocation of Tezpur University to be held at Tezpur University on 7<sup>th</sup> April, 2017. Duly filled tender document (*as per proforma enclosed herewith*) along with necessary supporting document should reach 'Joint Registrar, Tezpur University, Tezpur, 784028, Assam' on or before 29th March, 2017 upto 14:00 hrs. The sealed cover must be superscribed with **"Tender for Providing Snacks/Refreshment Packets for XIVth Convocation of Tezpur University along with the Quotation Notice No. and date".** 

## **Terms and Conditions**

- (a) No separate tender paper will be issued from the office; one should only download from the University Website. The rates should be exclusive of taxes and applicable tax (%) should be clearly indicated.
- (b) Quotation should be accompanied with non-refundable processing fees (in the form of Demand Draft) of Rs. 2,000/- (Rupees Two-Thousand) only drawn in favour of 'Registrar, Tezpur University', payable at Tezpur.
- (c) Approximate number of packets to be served is 1500. However, the number may vary and the final numbers of packets to be served will be intimated before starting of the programme.
- (d) Food grade packaging is required to supply the items at the venue. Cost of packaging must be included in the rates quoted by the vendors.
- (e) Food items must be prepared by using reputed brand ingredients only.
- (f) Quoted rates should be valid at least for a period of 45 days.
- (g) Food committee will shortlist the items based on the tender submitted by various vendors. Each vendor need to supply minimum 5 packets with selected items to the committee for inspection of quality/taste/packaging etc.
- (h) The selection of vendor will be based on L1 rate and the quality/taste/packaging of the items. Lowest rate would not be sole criteria for selection of the party.
- (i) Last date of submission of the Quotation is 2:00 PM, 29<sup>th</sup> March, 2017.
- (j) No advance payment will be made to the vendor. The bill must be submitted by the vendor within 7 days after the programme is over for settlement.
- (k) Proportionate amount will be deducted, if the served items differs from the selected items in its quantity/quality etc.
- (I) The University reserves the right to accept or reject any or all the quotations without assigning any reason.
