No request for consideration of earlier deposited EMD will be considered. ii) A non-refundable application (quotation) fee of ₹.1000.00 (Rupees One Thousand) only must be paid only by Demand Draft drawn in favour of Registrar, Tezpur University payable at Tezpur.
- 4. The rates should be exclusive of GST and applicable GST in % should be clearly indicated.
- 5. Applicable levies, surcharge and discounts should be clearly indicated itemwise.
- 6. Quoted rates should be valid at least for a period of 01 year.
