# Creation of Online Repository for Management of Digitized Cultural Assets

#### 1. Description of the work:

The Centre with Potential for Excellence in Particular Areas (CPEPA), Tezpur University, has been able to generate a substantial amount digitized data on various aspects of the cultural practices of North-East India. These data can be classified into four different types of materials: a) video recordings, b) audio recordings, c) still photographs and d) textual descriptions. These digital cultural resources have been generated through documentations under different themes and sub-themes pertaining to the life and culture of the region.

The Centre needs a computerized management system for efficient storage, retrieval and searchability of the aforementioned data.

#### 2. Scope of Work:

The required data-management system should incorporate the following essential features:

- Creation of Application Interface for Administration and User Accessibility
- Creation of Application Masters
- Creation of Secure Login / Logout Application System
- Creation of Application Form to capture Metadata Information of Information Repository on different Element Attributes
- Storing Application Information in proper format in database for easy retrieval.
- System should allow extensive searching option to search the Information Repository. System should allow to create Customized queries for retrieval and analysis of data. System should allow multiple search criteria.
- System should have a provision to store the information of outdated data to Archives
- System should follow standard Security Mechanisms
- To be able to provide log for Time and user stamping of each usage
- To be able to prevent unauthorized access to servers and network log should be maintained for all the Transactions handled
- To be able to provide an end-to-end security model that protects data
- Audit trail will be monitored.

#### 3. Specifications:

- The Application has to be designed & developed as per Web Standards 3.0
- HTML 5.0, CSS 3.0, AJAX & Flash should be utilized to provide a seamless and technically enriched website with rich information
- The Application has to be designed with rich design patterns and Model View Controller (MVC) architecture
- The Application should be compatible with the latest browsers like Internet Explorer 8.0, Firefox, Opera, Safari, Chrome
- Front End Design: HTML 5.0, AJAX, Jquery, CSS, Javascript, JSON
- Backend Programming: PHP
- Backend Database: MySql 5.0 / PostgresSQL or Higher
- Application Framework: LARAVEL / Codeigniter / CakePHP
- Application Server: Apache (under Windows 2010)
- The suggested Framework should be capable of storing and retrieving data amounting to be not less than 40TB.

#### 4. Qualifying Criteria:

- 1. The Bidder should be a Company registered under the Companies Act, 1956 for at least 5 years as on 31.03.2018 and should have their registered office(s) in Assam. A copy of Trade License and the registration certificate to be submitted.
- 2. The Bidder must possess a valid:
  - i. Company Registration Certificate
  - ii. GST Registration Certificate
  - iii. PAN Number

- 3. The Bidder must be a profit-making company and should have positive net worth in each of the last three financial years as on March 31, 2018 (Net worth = Paid up Equity + Reserve Miscellaneous expenditure). Audited financial statements & CA Certificate must be enclosed.
- 4. The Bidder should have average annual turnover of at least INR 1 Crore for the last three financial years as on March 31, 2018. Audited balance sheet of the last three financial years must be enclosed.
- 5. The Bidder shall not be under a Declaration of Ineligibility for corrupt or Fraudulent Practices with any Government departments/ agencies/ ministries or PSU's and should not be debarred as on submission of the NIT. A declaration by authorized signatory of the Bidder must be enclosed.

Quotations should be accompanied by i) An EMD (in the form of Demand Draft/Call Deposit/TDR) of ₹. 3000.00 (Rupees Three Thousand) only drawn/pledged in favor of Registrar, Tezpur University, payable at Tezpur. - 4. All related Software (Open Source / Proprietary based) other than the Operating System required for development and future implementation must be the responsibility of the bidder with valid licenses. In no case any pirated/cracked/stolen version of the software would be acceptable.
- 5. Bidder must suggest minimum Hardware configuration of Server/Storage/Terminal etc. required to implement the application.
- 6. The offered solution must be easily scalable so that any future growth in data size can be easily accommodated in the application without any major modification in the source code.
- 7. The fully developed application software must be ready for delivery within 4 months after placing of the Work Order/Contract. In no way partial developed software would be accepted.
- 8. Price validity of the offer must be six (6) months from the date of opening of the tender.
- 9. Onsite training must be provided to the individuals who would be associated in operating of the software.
- 10. Onsite technical support must be provided for initial 3 months of launch of the software application and rest 9 months may offsite either through remote logins/telephone etc. whichever is suitable.
- 11. Software Warranty: The bidder must provide warranty for a period of three (3) years from the date of acceptance of the application software.
- 12. AMC: The bidder must provide post warranty maintenance charges.
- 13. Performance Bank Guarantee of 10% of the Order value must be provided for the period of warranty.
- 14. Payment Terms: Payment would be released after successful completion and acceptance of the software project.
- 15. All other terms and conditions which fall under GFR must apply.
- 16. The rates should be exclusive of GST and applicable GST in % should be clearly indicated.
