Qualifying criteria for interested contractor/bidder :

1. Registered with Govt./Semi Govt. Departments/Autonomous Bodies in appropriate class
2. Minimum Annual Turn over from Construction works during last 3 consecutive years shall not be less than **8.00 lakhs**.
3. Should have **completed** satisfactorily similar installation / commissioning of minimum 06 (six) nos. Deep Tube-well up to a depth of 100.00 Metre in reputed organisations like Central / State Govt., Local body like Corporation / Municipalities, Public Sector undertakings etc.supported by **work order and completion certificate**.
4. **Complete Tender document must be uploaded alongwith scanned copies of qualifying documents** as per the qualifying criteria as stated in serial no.1,2 and 3 above along with PAN and GST . Tenderers will be required to upload the scanned copies of the Demand Draft against tender fee (non-refundable) and Earnest Money drawn in favour of the Registrar, Tezpur University payable at Tezpur. Tezpur University reserves the right to accept or reject any or all the tender document without assigning any reason thereof . The original Tender Fee and EMD should be submitted or reach the Registrar, TU before the bid opening date.
5. Downloading of tender paper by a contractor does not automatically mean that the tenderer is considered qualified for the work.
6. The acceptance of tender will rest with the authority of Tezpur University, Napaam , Tezpur who does not bind itself to accept the lowest tender and reserves to itself the right to reject any or all the tenders received without assigning any reason thereof. The work may be allotted in part or whole at the discretion of competent authority of the University.
