2. Having Valid Electrical contractor's license.
3. Having PAN and GST Registration.
1. Should have **completed** satisfactorily 01 (one) electrical works value not less than **Rs.1.90 lakh** or two electrical works value not less than **Rs.1.19 Lakh** each or 03 (three) electrical works value not less than **Rs.0.95 Lakhs** each in last 07 (seven) years in Govt./ Semi Govt. Department/Autonomous Body **supported by work orders and completion certificates**
2. Original Bid Security Declaration in Affidavit and tender fee (non-refundable) must be submitted in a sealed envelope to be super scribed this tender name & the name of your agency and must reach *the Registrar, Tezpur University* before the last date & time for receipt of Bid. ***Tender without the Bid Security Declaration and Tender Fee (Non-refundable) will be summarily rejected.***
3. In Case of digital mode payment receipt of the payment is to be submitted.
