Should have **completed** satisfactorily Civil works of (i) *one work* of value not less than **1.09 Lakh** *against single work order* **OR** (ii) two works of value not less than **0.68 Lakh** each against *two separate work orders* **OR** (iii) three works of value not less than **0.55 Lakh** each against *three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate**.
- 4. The tenderer shall sign and stamp each page of this tender document as a token of having read, understood and comply with tender, the terms and conditions contained herein. This tender document is required to be uploaded on the website https://eprocure.gov.in along with scanned copies PAN, GST and other qualifying documents, as per the qualifying criteria stated above in serial no.1,2 and 3.
