2. Average Annual Turnover during for last 3 consecutive financial years shall not be less than **0.46 lakhs.**
3. Should have **completed** satisfactorily Civil works (Buildings) of (i) *one work* of value not less than **1.12 Lakh against single work order OR** (ii) two works of value not less than **0.70 Lakh** each against *two separate work orders OR* (iii) three works of value not less than **0.56 Lakh** each against *three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate.**
4. The tenderer shall sign and stamp each page of this tender document as a token of having read, understood and comply with tender, the terms and conditions contained herein. This tender document is required to be uploaded on the website <https://eprocure.gov.in> along with scanned copies PAN, GST and other qualifying documents, as per the qualifying criteria stated above in serial no.1,2 and 3.
