Tenderers will be required to deposit Demand Draft drawn in favour of The Registrar, Tezpur University payable at Tezpur or through any digital mode at Tezpur University cash Counter for purchase of Tender Document. The Tender fee is non-refundable. Cash Counter remain open upto 1.00 pm on all working days. Tezpur University reserve the right to accept or reject any or all the tender document without assigning any reasons thereof. A bid Security Declaration in lieu of EMD should be submitted in an affidavit which is enclosed along with this tender as **Annexure-I**
