- 2. Minimum Annual Turnover during last 3 consecutive financial years shall not be less than **0.44** lakhs.
- 3. Should have **completed** satisfactorily civil work of (i) *one work* of value not less than **1.07 Lakh** *against single work order* **OR** (ii) two works of value not less than **0.67Lakh** each against *two separate work orders* **OR** (iii) three works of value not less than **0.53 Lakh** each against *three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate**.
- 4. The tenderer shall sign and stamp each page of this tender document as token of having read, understood and comply with tender, the terms and conditions contained herein. This tender document is required to be uploaded on the website https://eprocure.gov.in along with scanned copies PAN, GST and qualifying documents, as per the qualifying criteria stated above in serial no.1,2 and 3. Incomplete bid/documents shall be rejected without giving any reason. There is no need to submit the hard copy of the Tender and other documents except Original Bid Security Declaration & Declaration regarding correctness of information submitted in this Tender as per NIT in affidavit and tender fee (non-refundable).
