- 1. Registered with Govt./Semi Govt. Departments/Autonomous Bodies .
- 2. Average Annual Turnover for any 3 consecutive financial years during last 5 years, starting from Financial Year 2016-17, shall not be less than **0.14 lakhs.**
- 3. Should have **completed** satisfactorily Civil works of (i) *one work* of value not less than **0.34 Lakh** *against single work order* **OR** (ii) two works of value not less than **0.21 Lakh** each against *two separate work orders* **OR** (iii) three works of value not less than **0.17 Lakh** each against *three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate**.
- 4. The tenderer shall sign and stamp each page of this tender document as a token of having read, understood and comply with tender, the terms and conditions contained herein. This tender document is required to be uploaded on the website https://eprocure.gov.in along with scanned copies PAN, GST and other qualifying documents, as per the qualifying criteria stated above in serial no.1,2 and 3. Original Bid Security Declaration & <u>Declaration regarding correctness of information submitted in this Tender as per NIT</u> in Affidavit and tender fee (non-refundable) must be submitted in a sealed envelope to be super scribed this tender name & the name of your agency and must reach *The Registrar*, *Tezpur University* before the last date & time for receipt of Bid. *Tender without the Bid Security Declaration and Tender Fee (Non-refundable) will be summarily rejected.*
