Should have **completed** satisfactorily RCC 2-storied building of (i) *one work* of value not less than **236.06 Lakh** *against single work order* **OR** (ii) two works of value not less than **147.54 Lakh** each against *two separate work orders* **OR** (iii) three works of value not less than **118.03 Lakh** each against *three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate**.
- 4. Bidders who meet the minimum qualification criteria will be qualified only if their available bid capacity at the expected time of bidding is more than the total bid value.
