- 2. Average Annual Turnover from Electrical works in any 3 years during last 04 years shall not be less than 0.45 lakhs.
- 3. Should have **completed** satisfactorily Electrical Works of (i) *one work* of value not less than **1.08 lakhs** *against single work order* **OR** (ii) two works of value not less than **0.68 lakhs** each against *two separate work orders* **OR** (iii) three works of value not less than **0.54 lakhs** each against *three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate**.
- 4. The tenderer shall sign and stamp each page of this tender document as token of having read, understood and comply with tender, the terms and conditions contained herein. This tender document is required to be uploaded on the website https://eprocure.gov.in along with scanned copies PAN, GST and qualifying documents, as per the qualifying criteria stated above in serial no.1,2 and 3. Incomplete bid documents shall be rejected without giving any reason. There is no need to submit the hard copy of the Tender Document and other documents except Original Declaration regarding correctness of information submitted in this Tender as per NIT in affidavit (As per Annexure V), Tender Fee (non-refundable) and Earnest Money Deposit(refundable)
- **5.** Bidders will be required upload the scanned copies of the Demand Draft against tender fee (non-refundable) and EMD (Earnest Money Deposit) drawn in favour of the Registrar, Tezpur University payable at Tezpur along with the Declaration regarding correctness as per NIT in affidavit and other qualifying documents as per tender and sealed and signed tender document.

Declaration regarding correctness of information submitted in this Tender as per NIT in Affidavit and Tender fee (non-refundable) and EMD (Earnest Money Deposit) must be submitted in a sealed envelope to be super scribed this tender name & the name of your agency and must reach The Registrar, Tezpur University before the last date & time for receipt of Bid. Tender without the Tender Fee (Non-refundable) and EMD (Earnest Money Deposit) will be summarily rejected.
- 7. <u>Bidder's Technical capability will be determined as per the format given in **Annexure-VI.** Technically disqualified bidder's price bid will not be opened and will not be considered for the next step.</u>
