- 2. Average Annual Turnover from Civil works in any 3 years during last 04 years shall not be less than **0.35** lakhs
- 3. Should have **completed** satisfactorily Civil Works of (i) *one work* of value not less than **0.86 lakhs** *against single work order* **OR** (ii) two works of value not less than **0.54 lakhs** each against *two separate work orders* **OR** (iii) three works of value not less than **0.43 lakhs** each against *three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate**.
- 4. The tenderer shall sign and stamp each page of this tender document as token of having read, understood and comply with tender, the terms and conditions contained herein.  - (d) Annual turnover certificate from Chartered Accountant.
 - (e) PAN.
 - (f) GST Registration.
 - (g) Work order(s) & completion certificate(s) to satisfy the Sl. No. 3 of qualifying criteria of this NIT.
