Should have completed satisfactorily Civil Works of (i) one work of value not less than **1.08** lakhs against single work order OR (ii) two works of value not less than **0.67** lakhs each against two separate work orders OR (iii) three works of value not less than **0.54** lakhs each against three separate work orders during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by work order and completion certificate.
- 4. The tenderer shall sign and stamp each page of this tender document as token of having read, understood and comply with tender, the terms and conditions contained herein.  - (d) Annual turnover certificate from Chartered Accountant.
 - (e) PAN.
 - (f) GST Registration.
 - (g) Work order(s) & completion certificate(s) to satisfy the Sl. No. 3 of qualifying criteria of this NIT.
