Incomplete bid documents shall be rejected without giving any reason. <u>There is no need to submit the hard copy of the Tender</u> <u>Document and other documents</u> except Original Declaration regarding correctness of information submitted in this Tender as per NIT in notarized affidavit (As per Annexure V), Tender Fee (non-refundable) and Earnest Money Deposit (refundable)
- **3.** Bidders will be required upload the scanned copies of the Demand Draft against tender fee (non-refundable) and EMD (Earnest Money Deposit) drawn in favour of the Registrar, Tezpur University payable at Tezpur along with the Declaration regarding correctness as per NIT in notarized affidavit and other qualifying documents as per tender and sealed and signed tender document.

 - (*d*) PAN.
 - (e) GST Registration.
- 6. <u>Bidder's Technical capability will be determined as per the format given in Annexure-VI.</u> <u>Technically disqualified bidder's price bid will not be opened and will not be considered for the next step.</u>
