- (a) **For the PG programmes**, the candidates are required to report on **30th July, 2024 at 9.30 A.M.** in the concerned department for credential verification and admission.
- (b) **For the B.Tech. programme**, the candidates are required to report on **14th August, 2024 at 9.00 A.M.** in the KBR Auditorium, Tezpur University for credential verification and admission.

Documents to be submitted:

- (i) Mandatory documents to be produced at the time of physical verification and admission submit self-attested copies of the same for official record during admission:

- Two copies of recent passport size photograph.
- A print copy of the online filled application form.
- Certificate of HSLC / Class 10/Class 10+2 having date of Birth.
- Medical certificate as per Annexure duly signed by Registered Medical Practitioner.
- Pass certificates of all examinations starting from HSLC or equivalent examination conducted by the Board/ Council (except pass certificate of the qualifying examination if the result is awaited).
- Mark sheets/ grade cards of all examinations starting from HSLC or equivalent examination conducted by the Board/ Council (except marksheet of the qualifying examination if the result is awaited).
- A character certificate from the Head of the institution last attended.

(ii) Provision for late submission of documents under “Provisional Admission”:

1. Gap certificate (in original) from the District Police Authority or Court Affidavit, in case of a gap in study for more than one year after the qualifying examination.
2. Duly filled in undertaking (A or B) signed by the candidate and his / her parent/ guardian along with other documents at the time of admission.
3. Migration Certificate (original copy to be submitted).

The candidates admitted under the provision of “Provisional admission” must produce all pending documents by 30th November 2024 failing which their candidature will be cancelled.
